Regular Session -

The City Council of the City of Lanett, Alabama, met on Monday, May 04, 2020, in the Council Chambers located at Lanett City Hall at 6:00 P.M.

Council members present were Tony Malone, Jamie Heard, Charles Looser, and Angelia Thomas. Mayor Kyle McCoy presided over the meeting.

Replacing the invocation was a moment of silence in memory of Mr. Bobby Williams. The pledge of allegiance was led by Captain Richard Casner.

Mayor Kyle McCoy welcomed everybody.

The Agenda was approved through a motion by council member Malone and seconded by council member Thomas. Motion unanimously carried.

The first reading of Ordinance 05-20-01 to increase pay for Fire/EMS and Police was read by City Clerk Deborah Gilbert.

Motion unanimously carried. Fire Chief Johnny Allen explained the need for the grants that would be for equipment and other safety items.
