

City of Lanett Meeting Minutes City Council

Monday, December 21, 2020

Public Hearing -

The City Council of the City of Lanett, Alabama, held a Public Hearing on Monday, December 21, 2020, in the Council Chambers at City Hall at 6:00 P.M Grant writer, Louise Campbell was present to lead the meeting. She stated that the purpose of this meeting was to solicit citizen input in regards to the Community Block Development Grant for Streetscape work. Great bids were received on this program therefore an amendment should be done for paving for North Lanier to the state line. The cost is approximately \$91,000. We are asking Council to approve through a motion the formal amendment to ADECCA as well as approval to submit a change order on the original.

Regular Session -

The City Council of the City of Lanett, Alabama, met on Monday, December 21, 2020, in the Council Chambers at City Hall at 6:10 P.M.

Council members present were Tony Malone, Jamie Heard, Angelia Thomas, Charles Looser and Tifton Dobbs. Mayor Kyle McCoy presided over the meeting.

The Invocation was given by Reverend Rodney Jones. Mayor McCoy led the pledge of allegiance.

Mayor McCoy asked for a motion to amend the Agenda by adding Resolutions 12-20-09 and 12/20-10 to deal with the action needed from the Public Hearing. Councilman Malone made the motion and Councilwoman Thomas seconded amending the Agenda.

The Agenda as amended was approved through a motion by council member Thomas and seconded by council member Looser. Motion unanimously carried.

The Minutes from November 16th meeting, December 7th meeting, November 16th Work Session and December 16th Work Session were approved through a motion by council member Dobbs and seconded by council member Thomas. Motion unanimously carried.

Under New Business Mayor Kyle McCoy asked for a motion for approval of Invoices as submitted by the Clerk/Treasurer. Council member Malone made the

motion and council member Dobbs seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-01, a Resolution authorizing contract renewal with AVENUE Insights & Analytics, LLC. by council member Dobbs. Council member Thomas seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-02 a Resolution to reject all bids for 2020-ELE-03 by council member Malone. Council member Dobbs seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-03 a Resolution to accept the negotiated bid from Over and Under Contractors for pole replacement along N. Lanier Ave. by council member Dobbs. Council member Malone seconded the motion. Motion unanimously carried.

Resolution 12-20-04 to accept the proposal of Clearwater Solutions to operate the Water Distribution/Sewer Collection System was motioned by Councilman Looser made a motion to approve with Councilman Malone seconding. Councilman Dobbs requested and made a motion to table Resolution 12-20-04 due to the fact that he felt rushed and that there was not enough time to approve it without questions. Council member Thomas seconded the motion to table this resolution until the January 4, 2021 meeting. At the December 21st meeting concerning Resolution 12-20-04, the chair entertained a motion by councilmember Dobbs to table resolution. Council members appeared to assent to the motion but no vote was recorded. In an effort to clarify minutes and the motion to table this matter, the chair will entertain a vote concerning a motion to table Resolution 12-20-04, which was previously done by assent.

A motion was made to adopt Resolution 12-20-05 a Resolution to approve a lease with Chambers County Development Authority for Airport office space by council member Thomas. Council member Dobbs seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-06 a Resolution to approve contract with Municipal Gas Authority of Georgia by council member Looser. Council member Thomas seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-07 Appointment of Johnny Allen to Board of Directors for Chattahoochee Valley Water Supply District by council member Dobbs. Council member Thomas seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-08 Appointment of Terry Reed to Board of Directors for Chattahoochee Valley Water Supply District by council member Malone. Council member Dobbs seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-09 to approve the submission of a formal amendment to the Community Development Block Grant for resurfacing by council member Thomas. Council member Dobbs seconded the motion. Motion unanimously carried.

A motion was made to adopt Resolution 12-20-10 to approve a change order after review and approval by ADECCA to the Community Development Block Grant by council member Malone. Council member Dobbs seconded the motion. Motion unanimously carried.

Reports of Standing Committees:

Councilman Tony Malone- Councilman Malone had no committee report. He wished all citizens a Merry Christmas and a happy 92nd birthday to Mrs. Bobbie Greenwood. Mr. Malone presented a proclamation in recognition of Mrs. Rudene McCoy's 92nd birthday, naming this day in her honor. Attorney Skip McCoy thanked the city on behalf of their family.

Councilman Jamie Heard- Councilman Heard had no committee report. He wished everyone a merry Christmas and a happy New Year.

Councilman Charles Looser- Councilman Looser had no committee report. He thanked all the city employees for a job well done.

Councilwoman Angelia Thomas- Councilwoman Thomas had no committee report. She wished everyone a merry Christmas and also thanked employees for their hard work.

Councilman Tifton Dobbs – Councilman Dobbs had no committee report. He wished everyone a merry Christmas and asked everyone to remain safe over the holidays.

Mayor McCoy announced that on December 31, 2020 at 6:00 p.m. the city would
release balloons on playground on 1st Street in memory of someone that was lost
this year and in honor of someone that was still struggling.
