## **Regular Session -**

The City Council of the City of Lanett, Alabama, met in regular session on Monday, November 1, 2021, in the Council Chambers of the Lanett Municipal Complex at 6:00 P.M.

Council members present were Tony Malone, Tamalita Autry, Angelia Thomas, Charles Looser and Tifton Dobbs. Mayor Heard presided over the meeting.

Rev. Rodney Jones said the invocation and Mayor Heard led the pledge of allegiance.

Councilmember Looser made the motion to adopt the prepared agenda. Councilmember Dobbs seconded the motion. Motion unanimously carried.

Councilmember Dobbs made the motion to approve the minutes of the October 18, 2021 Council Meeting and October 25, 2021 Work Session. Councilmember Malone seconded the motion. Motion unanimously carried.
