The City Council of the City of Lanett, Alabama, met on Monday, September 21, 2020, in the Council Chambers at City Hall at 6:00 P.M.

Council members present were Tony Malone, Jamie Heard, Angelia Thomas, Charles Looser and John Motley. Mayor Kyle McCoy presided over the meeting.

The Invocation was given by Reverend Rodney Jones. Mayor McCoy led the pledge of allegiance.

The Agenda was approved through a motion by council member Malone and seconded by council member Thomas. Motion unanimously carried.

The Minutes from August 3rd meeting were approved through a motion by council member Heard and seconded by council member Motley. Motion unanimously carried.

Resolution 09-20-11 a Resolution to approve the demolition of city owned property adjacent to the municipal airport was motioned by Councilmember Heard and seconded by Councilmember Motley. Motion unanimously carried.

Councilman Tony Malone- Councilman Malone had no committee report. He had questions about reopening the city parks. Mayor McCoy stated that this would be re-addressed after Governor Ivey gave an update in October.

Councilman Jamie Heard- Councilman Heard had no committee report.

Councilwoman Angelia Thomas- Councilwoman Thomas had no committee report. She stated that in her district, she was still distributing signs to citizens for their efforts at keeping the city well groomed.

Mayor McCoy stated that the preliminary 2021 budgets were being processed and would be ready for the council to review shortly and that the city audit would be starting soon.
