Regular Session -

The City Council of the City of Lanett, Alabama, met in a regular meeting on Monday, February 5, 2024, in the Council Chambers of the Lanett Municipal Complex at 6:00 P.M.

Council members present were Tony Malone, Tamalita Autry, Ronnie Tucker, Angelia Thomas and Tifton Dobbs. Mayor Jamie Heard presided over the meeting. Rev. Tifton Dobbs said the invocation and the pledge of allegiance.

Councilmember Tucker made the motion to approve the agenda. Dobbs seconded and the motion unanimously carried.

Councilmember Thomas made the motion to approve the minutes of the January 22, 2024, Council Meeting and Work Session. Councilmember Dobbs seconded the motion. Motion unanimously carried.

Approval of Invoices was motioned by Councilmember Thomas and seconded by Councilmember Dobbs. Motion unanimously carried.

Resolution 02-24-01 Determination of Public Nuisance and Authorization for action against Christopher and Tina Kelley was put in motion by Councilmember Dobbs and seconded by Councilmember Thomas. Motion unanimously carried. Code Enforcement Officer Johnny stated that this Resolution, along with the next three were for properties that the owners had already been contacted but took no steps to clear up the issue. We now ask for permission to proceed with demolition.

Resolution 02-24-02 Determination of Public Nuisance and Authorization for action against Karl Scott was put in motion by Councilmember Thomas and seconded by Councilmember Dobbs. Motion unanimously carried.

Resolution 02-24-03 Determination of Public Nuisance and Authorization for action against Jeremy Smith was put in motion by Councilmember Dobbs and seconded by Councilmember Thomas. Motion unanimously carried.

Resolution 02-24-04 Determination of Public Nuisance and Authorization for action against Billy Spears was put in motion by Councilmember Tucker and seconded by Councilmember Thomas. Motion unanimously carried.

Councilmember Malone had no committee report. He stated that this is Black History Month. He encouraged all citizens to take part in any event taking place throughout the month.

Councilwoman Autry was absent.

Councilman Tucker had no committee report.

Councilwoman Thomas had no committee report. She thanked the Airport committee as well as the Code Enforcement Officer for what he was doing. She encouraged citizens to keep their properties clean. She also thanked Michael Sides and the water department.

Councilman Dobbs had no committee report.

Mayor Heard motioned to go into Executive Session to discuss a pending competitive project. A roll call resulted in the following votes:
