## **Regular Session -**

The City Council of the City of Lanett, Alabama, met in a regular meeting on Monday, March 3, 2025, in the Council Chambers of the Lanett Municipal Complex at 6:00 P.M.

Councilmembers present were Tony Malone, Ronnie Tucker, Angelia Finley Thomas and Tifton Dobbs. Mayor Jamie Heard Dobbs presided over the meeting.

Chaplain Rev. Rodney Jones said the invocation and Mayor Heard led the pledge of allegiance.

At this time Code Enforcement Officer Johnny Wood came forward for a Public Hearing for Nuisance and Property Abatement for Red Door Properties, Homer Cowart and Andrae Chambers. No one was present to address issues. Chambers had previously reached out to Wood for arrangements.

Councilmember Malone made a motion to approve the agenda. Councilmember Dobbs seconded the motion. Motion carried unanimously.

Resolution 03-25-07 a resolution to determine a Public Nuisance and Authorize Action on property owners Red Door Properties was put in motion by Councilmember Thomas and seconded by Councilmember Tucker. Motion unanimously carried.
